

Licensing Act 2003 - Applications completed in 2018

Please find below a list of Licensing Act 2003 applications completed since 1 January 2018 by the Licensing Authority, Worthing Borough Council, for new Premises Licences, Variations to existing Premises Licences and Review applications.

The terms of the Licensing Act 2003 dictate that all 'new' application and 'variation' applications are publicised and consulted on. If no representations are received from 'Responsible Authorities' or any other persons such applications must be granted as applied for. If relevant representations are received and mediation between the parties is unsuccessful then the application has to be deliberated by a sub-committee of the Licensing & Control Committee B following a hearing.

'Minor variations' are also consulted on but only by 'public notice' on the premises, details posted on this website and any responsible authorities the licensing authority selects as relevant. If relevant representations are received and considered by officers to have implications under the licensing objectives then the application is simply rejected and a full variation has to be applied for.

'Review' applications cannot be withdrawn unless a licence is surrendered and must be heard by the full Licensing Committee B whatever agreement mediation may produce.

Coast Café

An application for a minor variation to the premises licence at the 'Coast Cafe'. The cafe is situated in the West Chalet Kiosk on Beach Parade, Worthing, BN11 2FG. The licence authorises the sale of alcohol for consumption on the premises from 11:00hrs to 23:45hrs Sunday - Thursday and 11:00hrs to 00:45hrs, of the following morning, Friday & Saturday and the provision of regulated entertainment.

The application sought to authorise:

 Alterations to the layout of the premises as part of a refurbishment to incorporate a larger repositioned servery to allow the installation of new coffee and smoothie machines.

The representation from a local resident concerned the noise from the proposed provision of entertainment. As a result of mediation the applicant withdrew the application for entertainment.

As both representations were addressed an amended licence was granted as per the terms of the Licensing Act 2003.

Its premises licence permits the sale of alcohol for consumption on & off the premise between 11:00hrs and 02:00hrs (of the following morning) Monday to Wednesday, 11:00hrs and 02:30hrs Thursday & Friday, 11:00hrs and 03:00hrs Saturday and 12:00hrs and 00:30hrs Sunday. The licence also authorises the provision of regulated entertainment.

The application was submitted by Sussex Police and sought:

Revocation of the licence.

The grounds for review being the applicant's contention that the licence holder has seriously undermined the following licensing objectives:

- The prevention of Crime & Disorder
- Public Safety

by poor management, lack of adherence to licence conditions, high levels of intoxication within the premises and the constant and persistent volume of incidents in and around the premises.

This application was originally considered by the Licensing & Control Committee in September 2017. The Committee's decision to revoke the licence was appealed by the licence holder to the Magistrates' Court.

The application has now been remitted back to the Licensing Authority for re-hearing by the courts under section 181 part 2C of the Licensing Act. As part of the re-hearing process the application was re-consulted on.

Committee Hearing: Held on Tuesday 11 September 2018

Due to the nature of this application a hearing must be held by the full Licensing & Control Committee B.

The Licensing Act encourages mediation and in this case was eventually successful. Sussex Police and the licence holders requested that the Committee imposed a number of new conditions on the licence that had been agreed between the parties.

The Licensing and Control Committee B resolved to accept the mediated agreement between the parties as presented to the Committee. Agreeing to impose a comprehensive new list of conditions on the Premises Licence to replace the existing conditions.

Members recognised that there were failures under the previous management but that the mediated arrangement should assist the current management rectify these problems. The Police being experts in crime and disorder had agreed jointly with the premise holder that these were necessary and proportionate and a workable solution for the premises licence holder to operate, to ensure they remain legally compliant and promote the licensing objectives of crime and disorder and public safety. The Committee acknowledged there is now a good working relationship between the Police and the Premises Licence Holders and requires this to continue

It was recognised that the agreed conditions had resolved the West Sussex County Council Public Health representation in relation to these premises.

Churchill's Newsagents

An application for a 'full' variation to the premises licence at 'Churchills Newsagents'. The store is situated at 115 Montague Street, Worthing, BN11 3BP. Its premises licence permits the sale of alcohol for consumption off the premise between 09:00hrs and 22:00hrs Monday to Sunday incl. with opening hours of 06:00hrs to 22:00hrs Monday to Sunday authorised.

This application sought to extend the hours for the sale of alcohol and the opening hours of the store. The hours the licence holder sought being:

- Sale of alcohol
 - o 07:00hrs to 00:00hrs (midnight) Sunday Wednesday
 - o 07:00hrs to 01:00hrs (of the following morning) Thursday Saturday
- Opening to the Public
 - o 07:00hrs to 00:00hrs (midnight) Sunday Wednesday
 - o 07:00hrs to 01:00hrs (of the following morning) Thursday Saturday

No changes to the licensable activities provided were proposed by this application and all conditions of licence to remain unchanged.

Consultation closed: Sunday 4 March 2018 **Committee Hearing:** Cancelled – not required

Consultation was extended and the hearing was re-scheduled due to applicant's initial failure to advertise the application in line with the regulations.

No relevant representation was received from members of the public or the responsible authorities. As a result an amended licence was granted as per the terms of the Licensing Act 2003.

Worthing News

An application for a new premises licence for a newsagents/convenience store known as 'Worthing News'. The shop is situated at 25 Rowlands Road, Worthing, BN11 3JJ.

The application sought authorisation for the sale of alcohol for consumption off the premises.

- Sale of Alcohol:
 - o 07:00hrs to 23:00hrs Monday Sunday incl.
- Opening to the public:
 - o 07:00hrs to 23:00hrs Monday Sunday incl.

The applicant offered a number of enforceable conditions to address the licensing objectives.

The premises has been licensed in the past and its licence revoked at review in December 2017. However, the business has changed ownership since.

Licence holder and applicant: Mr Ahmad Salehi **Consultation closed:** Sunday 4 March 2018 **Committee Hearing:** Cancelled – not required.

Consultation on this application resulted in one representation from a local ward councillor and one from a responsible authority (Sussex Police). The Licensing Act encourages mediation and this was conducted successfully with the police & ward councillor. Their concerns were addressed by the applicant volunteering a number of conditions that will become enforceable conditions of licence.

As a result all representations were withdrawn. As a result an amended licence was granted as per the terms of the Licensing Act 2003.

Pavilion Theatre & Denton Cafe

An application for a 'minor variation' to the premises licence at the 'Pavilion Theatre & Denton Cafe'. The venue is situated on Worthing Pier, the Promenade, Worthing, BN11 3PX. The licence authorised the sale of alcohol for consumption on the premises and the provision of regulated entertainment. The application sought to vary the existing Licence to authorise:

- The sale of alcohol for consumption on & off the premises.
- Removal of following conditions of Licence:
 - Conditions consistent with the Embedded Restrictions of the Justices' 'On' Licence (Licensing Act 1964)
 - Conditions consistent with the Specific Conditions of the Public Entertainment Licence.
 - o The Standard Conditions of the Public Entertainment Licence
 - The specific conditions converted from the Justices' 'On' Licence (Licensing Act 1964)

Its premises licence permits the sale of alcohol for consumption off the premise between 09:00hrs and 20:00hrs Monday to Saturday and between 11:00hrs and 17:00hrs Sunday with matching opening hours.

This application sought to extend the opening hours of the store without changing the hours for the sale of alcohol. The hours for opening the licence holder sought being:

- Opening to the Public
 - o 09:00hrs to 23:00hrs Monday Saturday
 - o 10:00hrs to 20:00hrs Sunday

No changes to the hours for licensable activity or the types of regulated activity provided were proposed by this application and all other conditions of licence to remain unchanged.

Licence holder and applicant: Mr Nikolay Nikolov Consultation closed: Friday 19 January 2018

Committee Hearing: Not required for a minor variation

For a minor variation application, in addition to the statutory public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved changes to the opening hours of the store that could potentially have implications to the licensing objectives Sussex Police and the Environmental Health Team were consulted.

Representation was received from Sussex Police based on the prevention of crime & disorder objective. The representation objected to the change of hours detailing a number of failings relating to the current conditions of licence and the applicant not providing details of how it was proposed to manage the periods when the shop was open, alcohol on display but no sales permitted.

Under the Licensing Act mediation of a Minor Variation application is not recommended. The minor variation process allows officers only two options:

- Grant the minor variation or,
- Refuse the application.

Consequently, the application in its current form was refused.

A minor variation application allows a licence holder to apply for a number of small variations to his/her premises licence that will not impact adversely on the licensing objectives. As a result of the representation and after due consideration it was viewed that the representation could have some substance and the issues highlighted could have an adverse effect on the objectives. This does not mean that what was proposed might not be granted but in the circumstances it was considered such a change to the licence, in the circumstances, should require the options of mediation and even a hearing if necessary and these options are unavailable under the minor variation process.

The applicant now has the option of re-applying under the 'full' variation procedure.

Brunswick & Thorn

An application for a new premises licence for cafe/wine bar to be known as 'The Brunswick & Thorn'. The venue is situated on the corner of Brunswick Road & Thorn Road, Worthing, BN11 3ND.

The application is seeking authorisation for the sale of alcohol for consumption on the premises.

- Sale of Alcohol:
 - o 11:00hrs to 23:00hrs Wednesday Sunday
 - o 11:00hrs to 17:30hrs Monday & Tuesday
- Opening to the public:
 - o 08:00hrs to 23:30hrs Wednesday Sunday

The applicant offered a number of enforceable conditions to address the licensing objectives. The premises has been licensed in the past as a public house & hotel latterly known as The Bay.

Licence holder and applicant: Brunswick & Thorn Ltd.
Consultation closed: Thursday 18 January 2018
Committee Hearing: Cancelled. Not required.

One representation was received from a member of the public (a local resident) and the application attracted a representation from a responsible authority (Sussex Police). The Licensing Act encourages mediation and this was successfully conducted between the applicant, Sussex Police and the resident with an amendment to the opening times on Sunday and a number of conditions being volunteered by the applicant that will become enforceable conditions of licence.

Consequently the Police and resident have withdrawn their objections. As a result an amended licence was granted as per the terms of the Licensing Act 2003.

Finch

An application for a new premises licence for a new cafe & bar. The venue to be situated at 27 Warwick Street, Worthing, BN11 3DQ.

The application sought authorisation for the sale of alcohol for consumption on the premises.

- Sale of alcohol
 - o 09:00hrs to 23:00hrs Sunday Thursday
 - o 09:00hrs to 23:30hrs Friday & Saturday
 - o 09:00hrs to 02:00hrs (of the following morning) New Year's Eve
- Opening to the Public
 - o 07:00hrs to 23:30hrs Sunday Thursday
 - o 07:00hrs to 00:00hrs (midnight) Friday & Saturday
 - 07:00hrs to 02:30hrs (of the following morning) New Year's Eve

The applicant has offered a number of enforceable conditions to address the licensing objectives.

Licence holder and applicant: MT Food & Drink Ltd. Consultation closed: Sunday 7 January 2018 Committee Hearing: Cancelled - Not required.

No representation was received from members of the public but the application attracted two representations from responsible authorities (Sussex Police & the Environmental Protection Team). The Licensing Act encourages mediation and this was conducted successfully. The authorities' concerns were addressed by the applicant volunteering a number of conditions that will become enforceable conditions of licence.

As a result Sussex Police & the Environmental Protection Team withdrew their representations and, consequently, an amended licence was granted as per the terms of the Licensing Act 2003.

Chef's Hat British Restaurant

An application for a 'minor variation' to the premises licence at the 'Chef's Hat British Restaurant'. The restaurant & bar is situated at 35/36 New Broadway, Tarring Road, Worthing, BN11 4HP.

In this case, as it involved a change to the licensable activities offered at the venue that could potentially have implications to the licensing objectives Sussex Police and the Environmental Health Team were consulted.

The Authorities made no representation and no formal representations were received from members of the public. After due consideration, it was decided that the changes proposed would have no adverse effect on the licensing objectives. Consequently, the minor variation was granted as per the terms of the Licensing Act 2003.
