

Licensing Act 2003 - Applications completed in 2019

Please find below a list of Licensing Act 2003 applications completed since 1 January 2019 by the Licensing Authority, Worthing Borough Council, for new Premises Licences, Variations to existing Premises Licences and Review applications.

The terms of the Licensing Act 2003 dictate that all 'new' application and 'variation' applications are publicised and consulted on. If no representations are received from 'Responsible Authorities' or any other persons such applications must be granted as applied for. If relevant representations are received and mediation between the parties is unsuccessful then the application has to be deliberated by a sub-committee of the Licensing & Control Committee B following a hearing.

'Minor variations' are also consulted on but only by 'public notice' on the premises, details posted on this website and any responsible authorities the licensing authority selects as relevant. If relevant representations are received and considered by officers to have implications under the licensing objectives then the application is simply rejected and a full variation has to be applied for.

'Review' applications cannot be withdrawn unless a licence is surrendered and must be heard by the full Licensing Committee B whatever agreement mediation may produce.

Pomodoro

An application for a new premises licence for a proposed new restaurant to be known as 'Pomodoro'. The venue to be situated at 47-49 Chapel Road, Worthing, BN11 1EG.

The application sought authorisation for the sale of alcohol for consumption on the premises.

One representation was received from a member of the public and the application attracted two representations from responsible authorities, in this case Sussex Police and the Environmental Protection Team.

The Licensing Act encourages mediation and this was conducted successfully. The concerns of the resident, Police and Environmental Protection Team were addressed by the applicant volunteering a number of conditions to the premises' operating schedule that will become an enforceable condition of licence in addition to those detailed in the application, amending the hours applied for on Friday & Saturday nights and dropping the application for regulated entertainments.

As a result an amended licence was granted as per the terms of the Licensing Act 2003.

Lucifer's Cafe Bar

An application for a new premises licence for a proposed new cafe-bar to be known as 'Lucifer's Cafe Bar'. The venue is situated at 58/62 Portland Road, Worthing, BN11 1QG.

The application sought authorisation for the sale of alcohol for consumption on the premises.

 - o 10:00hrs to 22:30hrs Sunday
 - o 10:00hrs to 00:00 (midnight) Monday Saturday
- Opening to the Public:
 - o 10:00hrs to 22:30hrs Sunday
 - o 10:00hrs to 00:00hrs (midnight) Monday Saturday
- New Year's Eve an extension until 01:00hrs of the following morning

The applicant offered a number of conditions in the operating schedule to address the licensing objectives

Licence holder and applicant: Mr Nick Brewer Consultation closed: Sunday 24 November 2019 Committee Hearing: Thursday 19 December 2019

Two representations were received from the public and the application attracted one representation from a responsible authority. In this case Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully with Sussex Police. The Police's concerns were addressed by the applicant volunteering a number of conditions to the premises' operating schedule that would become enforceable conditions of any licence granted in addition to those detailed in the application.

In addition the applicant amended the application to close the premises at 21:30hrs each day.

Consequently, Sussex Police and one of the residents withdrew their objections.

Mediation was unsuccessful with the remaining resident that had made representation so the application was referred to a Licensing & Control Sub-Committee to consider.

After hearing from all parties the Committee resolved that a premises licence should be granted in the following terms:

- Sale of alcohol:
 - o 10:00hrs to 21:00hrs Monday Sunday

- Opening to the public:
 - 10:00hrs to 21:30hrs Monday Sunday
- The licence to contain all the conditions agreed with Sussex Police prior to the hearing.

The Sub-Committee considered:

- the mediation during which the applicant had offered to amend the timings applied for and agreed to include the further licence conditions suggested by Sussex Police being placed on the licence.
- the remaining relevant representation which had not been withdrawn

and was satisfied that the additional conditions and amended opening hours specifically addressed the relevant concerns raised and as such the licensing objectives would not be undermined by the grant of this premises licence.

The Egremont

An application for a 'minor variation' to the premises licence at the 'Egremont'. The Public House is situated at 32 Brighton Road, Worthing, BN11 3ED. The licence authorises the sale of alcohol for consumption on & off the premises and the provision of regulated entertainment. The premises licence covers the building itself and a small forecourt area on the pavement directly outside the front of the venue. The application sought to vary the existing Premises Licence to amend a condition of licence.

The current licence condition states:

• All 'street furniture' (tables & chairs) to be cleared and brought inside by 23.00hrs on any day.

The proposed amended condition to read:

Heavy duty fixed 'street furniture' (tables & benches) to be provided in the designated outside area.
 These tables & benches to be cleared of drinks by 23:00hrs on any day.

No other changes were proposed by the application.

Licence holder and applicant: Mr Gregory Grundy **Consultation closed:** Thursday 5 December 2019 **Committee Hearing:** Not required for a minor variation

For a minor variation application, in addition to the statutory public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved changes to a condition of licence that could potentially have implications affecting the licensing objectives, Sussex Police and the Council's Environmental Protection Team were consulted.

Ten representations were received from members of the public in support of the application. However, it also attracted one representation from a member of the public and one from a responsible authority, in this case the Adur & Worthing Environmental Protection Team, objecting to the application based on the prevention of public nuisance objective.

Under the Licensing Act mediation of a Minor Variation application is not recommended. The minor variation process allows officers only two options:

- Grant the minor variation as applied for or,
- Refuse the application.

Consequently, the application in its current form was refused.

A minor variation application allows a licence holder to apply for a number of small variations to his/her premises licence that will not impact adversely on the licensing objectives. As a result of the representation

and after due consideration it was viewed that the representations could have some substance and the issues highlighted could have an adverse effect on the objectives. This does not mean that what was proposed might not be granted but in the circumstances it was considered such a change to the licence, in the circumstances, should require the options of mediation and even a hearing if necessary and these options are unavailable under the minor variation process.

The applicant now has the option of re-applying under the 'full' variation procedure

All in Onez

An application for a variation to the premises licence at the 'All in Onez' store. The shop is situated at 137 Clifton Road, Worthing, BN11 4DP. The licence currently authorises the sale of alcohol 08:00hrs to 23:00hrs Monday - Saturday and 10:00hrs to 22:30hrs on a Sunday.

The application sought:

- Extension of the hours for the sale of alcohol on Sunday to
 - o 08:00hrs to 23:00hrs
- Removal of a number of conditions present on the licence:
 - No more than 20% of the area available for display of retail goods will be used for the display of alcohol products
 - o No sales of beer, lager and cider over 6% ABV.
 - No sales of single cans or bottles of beer, lager and ciders containing less than 500ml. Sales
 of such cans and bottles to be in multiple packs of a minimum of four.
 - o No sales of miniature bottles of wine or spirit in units less than 35cl.

Four representations were received from members of the public but all were in support of the application. However, the application attracted one representation from a responsible authority. The Authority's concerns were addressed by the applicant volunteering a number of conditions to the premises' operating schedule that will now become enforceable conditions of licence in addition to those detailed in the application.

As a result an amended licence was granted as per the terms of the Licensing Act 2003.

The Police's concerns were addressed by the applicant volunteering a number of conditions to the premises' operating schedule that will become enforceable conditions of licence in addition to those detailed in the application.

As a result an amended licence was granted as per the terms of the Licensing Act 2003.

Beer No Evil

An application for a 'minor variation' to the premises licence at the 'Beer No Evil' Bar & Off Licence. The venue is situated at 82 Brighton Road, Worthing, BN11 2EN. The application sought to vary the existing Premises Licence to authorise:

- Extension of the licensed area of the premise to include the private pavement area directly outside
 the front of the premise (as shown on the plan) to provide an area for the consumption of food &
 drink by customers seated at tables & chairs situated within this area between 12:00 hrs & 21:00 hrs
 Monday Saturday and 12:00 hrs & 19:00 hrs Sunday. The maximum number of persons permitted at
 any time to use the forecourt area to be limited to 20 persons.
- Include the following conditions on the licence:
 - The forecourt area will be enclosed by removable barriers that will clearly separate the area from the public pavement. Customers will not be permitted to consume drinks outside this area. The barriers and all furniture will be removed from this area outside the permitted times. All patrons will be moved inside the premises once the area is closed.
 - There shall be no vertical drinking in the forecourt area. Customers consuming food & drink must be seated at tables.
 - CCTV will be installed covering the forecourt area.
 - Signage will be clearly displayed that requests patrons are mindful of noise and disturbance to neighbours. The area must be monitored regularly (at least every 15 minutes) and incidents of patrons found to be making excessive noise or disturbance must be addressed by staff. The contact details of the manager and designated premises supervisor will be made available to neighbours.
 - All drinks shall be served in 'toughened', 'poly-carbonate', 'plastic' or 'metal' glasses and no bottles will be allowed to be taken outside onto the forecourt. Tables will be cleared regularly to minimise the risk of empty glasses being knocked over and broken. The area will be kept tidy and any waste removed by staff. The area will be cleaned at the beginning and end of each day to ensure any waste and litter is removed.
- Amend the following conditions of Licence to state:
 - Vertical drinking will be limited to patrons within the premises. The will be no vertical drinking on the forecourt.
 - o A maximum of thirty (30) seats will be provided inside the premises for the use of customers.
 - O When a special event is held involving vertical drinking in the premises the Sussex Police Licensing Unit will be notified no later than fourteen (14) days prior to the date on which the event is to be held. On these occasions, a documented risk assessment must be written to identify the controls necessary to promote the licensing objectives. This will include but not be restricted to the need for SIA door supervisors, Polycarbonate drinking vessels. This document shall be immediately available for inspection by the Police and the Licensing Authority, upon request. In the event of a high risk assessment, the police will have the ability to prevent the event from going ahead on the grounds of the prevention of crime and disorder. If the police believe it is necessary and proportionate to prevent the event from taking place, they will submit their reasons,

No changes to the hours for licensable activity or types of regulated activity provided were proposed by this application and all other conditions of licence to remain unchanged.

For a minor variation application, in addition to the statutory public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved changes to the layout of the venue and conditions of licence that could

potentially have implications to the licensing objectives Sussex Police, the Environmental Protection Team and the West Sussex Fire & Rescue Service were consulted.

Representation was received from the Environmental Protection Team based on the prevention of public nuisance objective.

Under the Licensing Act mediation of a Minor Variation application is not recommended. The minor variation process allows officers only two options:

- Grant the minor variation or,
- Refuse the application.

Consequently, the application in its current form was refused.

A minor variation application allows a licence holder to apply for a number of small variations to his/her premises licence that will not impact adversely on the licensing objectives.
